## Ομιλία Διοικητή ΑΑΔΕ, Γιώργου Πιτσιλή, στο Συνέδριο της Ολομέλειας των Φορολογικών Διοικήσεων της ΕΕ (TADEUS), Ρόδος 15-16.09.2022

Dear colleagues and friends,

It is with great pleasure that I am welcoming you here in the historic island of beautiful Rhodes. I feel happy, proud and privileged to do so after the past few years of unprecedented crises, challenges and still amidst socio economic turbulence and national conflicts.

Before we start, I would like to say a few words about Rhodes that will help you understand why we chose this island of the Aegean apart from the obvious reason, its unique beauty of the landscape.

Rhodes is a crossroads of civilizations, a place where Greek and European history meet. It is the fourth largest Greek island and has a long and impressive history; it's a place where the strong medieval aspect blends with the ancient and byzantine Greekorigin and culture.

This Mediterranean gem boasts centuries'-old history: an adventurous and glorious past full of unexpected turns and twists of fate. It flourished during the 4th century BC and this is when the famous Colossus of Rhodes, considered one of the Seven Wonders of the world, was sculpted. One of the most interesting aspects of Rhodes' history is that each conqueror, each visitor and trader left their strong mark on the island and many of them are visible to date. Therefore you will see elements of the Roman, Byzantine and Ottoman Empires and of course, a strong and lasting mark of the Crusaders, the famous Knights Hospitaller. The latter rebuilt the city of Rhodes into a model of the

European medieval ideal and many of the city's famous monuments, including the Palace of the Grand Master, were built during this period.

It has already been 3 years since the last time we had the chance to meet in person in September 2019 in Helsinki. It was 4 years ago that we were here again in Greece where the idea of what soon after became TADEUS was born. So, for this reason as well, it is a happy occasion to hold a TADEUS Plenary meeting in its (conception and) birthplace.

TADEUS was established in Thessaloniki in an effort to develop a European level response to tax administration issues and challenges. It aims to collect experience, analyze data and share experience. Its goal is to positively influence the environment within which tax systems operate: to move away from a confrontational dialogue to more constructive two way engagement with businesses and taxpayers. It brings together DG'S from across Europe to share information and experience and toidentify good practices for resolving more complex issues and confront common challenges of the future.

The past few years of global crises changed the face of the world, changed our everyday lives and inevitably the way tax administrations act, react and respond to crisis and a constantly changing – both financially and socially - environment.
